At the same time parents or guardians must be aware that CSM does not provide any content filtering for Internet access. As a result students will have access to some or all of the following:

- Discussion groups and network news on many topics ranging from Chinese culture to the environment to music to politics;
- Access to Colorado Alliance of Research Libraries (CARL), many other university library catalogs, the Library of Congress and other libraries and databases.
